PRIVACY STATEMENT

This statement outlines how Kailis Bros Pty Ltd and its related entities or subsidiaries (the "Company") collect, use and manage personal information.

Collection of Personal Information

The Company may collect and hold personal information such as:

- Name;
- Address;
- Telephone numbers;
- Email addresses;
- Bank account and credit reference details; and

The information may be collected:

- directly from you;

- from publicly available information;
- from an individual's representative (i.e. spouse, business adviser); and
- from subsidiaries or related entities of Kailis Bros.

How the Company uses Personal Information

The Company may also use the personal information collected to:

- provide to likely or actual buyers of the whole or part of the Company's business or for internal restructuring purposes; and
- Register any security interest on the Personal Property Securities Register.

Disclosure of Personal Information

The Company may disclose your personal information to third parties including:

- government and regulatory authorities;
- The Company's professional advisers;
- An individual's representatives;
- Subsidiaries or related entities of the Company's; and
- To a likely or actual buyer of the whole or part of the Company or its business.

The Company may also supply personal information to its agents or contractors, including:

- Mailing services;
- Billing and debt recovery functions;

- Marketing functions.

Storing your Personal Information
